

Miami-Dade CAPE Academies

 M-DCPS increased the number of registered Career And Professional Education (CAPE) Academies by 20.6% from 155 in 2008-2009 to 192 in 2012-2013.



The total number of **students** participating in CAPE Academies increased by 152.75% from 17,668 in May 2008-2009 to 44,656 in May 2011-2012.







NAF CAREER ACADEMIES Select Metrics, Miami-Dade: District (Non-NAF) vs. NAF




Graduation Rate: Leading Indicators


Across grade matriculations, higher proportions of academy students on track to graduate in one year and remain on track to graduate the following year:

- grade 9 to 10: 63% NAF versus 58% non-NAF
- grade 10 to 11: 73% NAF versus 66% non-NAF
- grade 11 to 12: 77% NAF versus 74% non-NAF


INDUSTRY CERTIFICATION EXAMS IN FLORIDA, GRADES 9-12, 2012-13
